Privacy Policy

Information Collection and Use

SONARPUR CHOWPATHI PETER BELL ENGLISH SCHOOL is the sole owner of the information collected on this site. We will not sell, share, or rent this information to others in ways different from what is disclosed in this statement. SONARPUR CHOWPATHI PETER BELL ENGLISH SCHOOL collects information from our users at several different points on our Website.

Website Registration

In order to use some features of this Website, users must first complete the registration form. During registration, users are required to give their contact information (name and e-mail address). This information is used to contact users about the topics on our site for which they have expressed interest and to enable users to retrieve lost passwords.

Cookies

SONARPUR CHOWPATHI PETER BELL ENGLISH SCHOOL may use cookies to remember if users have logged in while on our site. This allows web site users to avoid logging in more than once, thereby saving time. Users have the option of disabling or not accepting cookies by changing the preferences on their browsers*. If users opt to disable cookies, they will still be able to use our Website. However, they will not be able to use some functionality or post to the message boards. No personally identifiable information (e-mail address, name, etc.) is collected with the cookies that we set. Accepting cookies while on the SONARPUR CHOWPATHI PETER BELL ENGLISH SCHOOL site will not put the user at risk for marketing to other sites.

Web Statistics

We use IP addresses to analyze trends, administer the site, track user movement, and gather broad demographic information for aggregate use for reporting and sponsorship purposes. IP addresses are not linked to personally identifiable information.

Sharing

We will share aggregated demographic information with our partners, sponsors, and donors. This is not linked to any personal information that can identify any individual person. We only share this information so that we can secure funding to continue providing services at a reasonable price.

Security

This Web site takes every precaution to protect our users' information, and we have security measures in place to protect the loss, misuse, and alteration of the information under our control.

Surveys
